

## President's Message by Sy Caudill

### My BAD!

In my last article I stated that members could attend BOD and Committee meetings of the association. If you would like to attend any of our meetings to either speak or listen we need to know in advance as our office meeting space is rather limited and meetings can run rather long depending on the topics. Please call the office and let our staff know that you would like to attend and they will put you on the list for that specific meeting. Same applies if you desire to present information, just let the staff know your topic and the Committee Chair will allocate a few minutes for you to present your position. Both of these will be on a first come basis and if space is an issue we may have to limit attendance. These actions are necessary to allow us to avoid overcrowding in a small office and for the BOD to accomplish our monthly agenda of business and actions. As always a chair may close a meeting and enter executive session at the chairs discretion. However, some open time will be available at all meetings if members sign up ahead of time for questions or comments. My apologies to those of you who showed up at the Parks and Safety meeting and were turned away, I should have been more detailed in my invitation to attend meetings and I should have had procedures in place.

Speaking of Parks and Safety, at the August BOD meeting the board voted to approve the following:

It is resolved that the position of the SHHA board of directors that SHHA will remain neutral in all of these matters; speed limits, emergency vehicle response time and speed bumps. Bernalillo County has the responsibility, processes and procedures in place for establishing/modifying speed limits, emergency vehicle response times and installation of speed bumps.

A great deal of controversy has arisen over these issues and we have a distinct division in our membership over them. Since the county has control we have determined that the best position for the organization is to facilitate communication between the county and our members while staying neutral as an association. Elsewhere in this issue is an announcement for a town-hall meeting chaired by the county on these issues. We would encourage members with input on these issues to attend and meet face to face with county representatives. Officers\directors of the association may be in attendance but they will be there in an unofficial capacity--speaking as individual homeowners. As a board and association we will remain neutral.

As you may have seen, we have been successful in getting road paving inside Sandia Heights and also on Tramway. Your association works these issues with our representatives and with county\state employees. We will continue to work these infrastructure issues as well as other issues relevant to our community but we need your help and volunteer support to keep these efforts alive. Please consider joining us. We have recently had two directors leave the association and would very much like to have volunteers sign up to replace these members--if you have some free time and would like to help improve your community please contact us at the office.

### Speed Resolution Studies in Sandia Heights

Hello GRIT readers. My name is Dave Mitchell, and I'm the County's Operations and Maintenance Director. Mr. Robert Baker is the County's Traffic Engineer within the O&M Department. I was asked, and am pleased to have the opportunity to write a guest column to explain the County's response to a recent request by the Traffic and Safety Committee of the Sandia Heights Homeowner's Association Board. The request was for an evaluation of San Rafael Avenue and Tramway Lane where 15mph speed humps exist currently.

A little background on speed limits and how they are set and changing them is in order. All Counties in New Mexico are technically arms of State government, so while the Counties can adopt independent Ordinances, Codes and Policies, they cannot supersede State Law. For speed limits, Bernalillo County does not have its own set of standards, but defers to the State Law governing evaluation and setting of speed limits. The County can perform a speed study to assess posted speed limits at its discretion based on any request that comes in. In addition the Federal Manual on **Uniform Traffic Control Devices** recommends studying speed limits every 5 years where changes are occurring, such as in Sandia Heights, where build out has occurred since the original speed limit signs were posted.

Obviously, a registered elected homeowner's or community association will always receive top consideration for an evaluation. Once the request is made, the criteria for a road's speed limit study is very well defined, and a standard form exists. Criteria include: 1. The type of terrain, ie: flat or rolling topography, 2. The type of development it serves ie: Residential, 3. The classification ie: major arterial, divided highway, or local undivided 4. The width, 5. Quality of the surface, 6. Shoulder conditions, 7. The sight distance along curves or hills, 8. Average daily traffic volume in vehicles per day, 9. Reported Accidents, and finally, 10,11 and 12. average and other statistical speeds as actually measured on the roadway, along with ranges of speeds by traffic.

What is not involved in this study is the question of whether speed humps should or should not exist. That is the purview of the County's Traffic Calming Policy for which there is no corresponding State statute. While the two questions are not tied, one affects the other, for example there exists different style speed humps for different posted speed limits.

At the time of this writing, the County has completed one study for all of San Rafael Avenue. Tramway Lane in the area of the speed humps only, will be complete by the time a town hall meeting is scheduled for the County to present its results for both roads.

Again, the studies currently ongoing are not looking at whether speed humps should stay or go, although there are some interesting data points that were collected for speeds in the hump zones. Mr. Baker, who is conducting the speed study, and I are looking forward to meeting with you at the scheduled town hall meeting. We'll provide copies of the studies, and take questions. We know that residents of Sandia Heights are a passionate, intelligent and opinionated group and like their voices to be heard. Maybe fortunately this is an area where there is not room for opinion against the State study.


# Bylaws Committee ~ Chair, Marsha Thole:

# SHHA PARKS AND SAFETY COMMITTEE

Sandia Heights offers its residents some of the most spectacular mountain and city scenery in New Mexico. We have parks in the heights and a long foot/bicycle path along Tramway Blvd. Unfortunately Sandia Heights does not have a system of foot trails. Joggers, bicyclers and pedestrians share our roadways with automobile traffic. One must always be alert to oncoming traffic and move off the road to let drivers go by. Pedestrian walkers should be in the oncoming automobile traffic lane so both the pedestrian and car driver can see each other. When a driver sees a person walking they usually move to the centerline and give the walker room. This is a coordinated maneuver and requires that both driver and pedestrian see each other and both take evasive action. Early morning, when it is cool, and in the evening after supper residents of



Sandia Heights jog or walk. This is especially true now in the summer, but many walk with their dogs and kids even in the winter.

The key safety feature for joggers, walkers, and bike riders is to be clearly seen by the oncoming automobile driver. This is generally not a problem during a cloudless midday but can be a problem early morning or during evening twilight. The SHHA does not recommend being on foot on any road in Sandia Heights when the visibility is bad. Walkers should consider the path along Tramway Blvd or drive over to the Elena Gallegos Park. This park is immediately south of Sandia Heights and has a vast array of foot trails. One can bring along a leashed dog. A year pass is available for about \$20. These trails are far from any automobile traffic.

Our concern is to address the existing reality of


many Sandia Heights residents who desire to walk, jog or bike ride on the roads in Sandia Heights. The SHHA office has available safety vests to be worn by residents when walking on our roads. The vests are colored an emergency orange and have highly reflective material sown into them. They should be worn day or night. The emergency orange color helps during the day and the reflective material helps make you visible in the evening or at night. The SHHA charges \$2 per vest for members and \$4 per vest for non-members. The vests are on order and will be available in September 2008. The vests can be purchased during normal business hours at the SHHA office on San Rafael near Tramway Blvd.

### **Recycling Update**



In response to homeowner questions about recycling

options, I spoke to Mr. Larry Buynak, manager of Sandia Heights Sanitation.

As you may know, sanitation is a part of Sandia Heights Services (SHS) and they provide our weekly trash pickup. They also will pick up large items such as furniture for a modest fee, if you call in advance. Although the city of ABQ does provide curbside recyclable pickup, there is no such provision for recyclables here in the SHHA area. True, the underlying reason may be financial but it's more complex than that. The winding and narrow roads of our neighborhood present a special challenge to SHS trash collection trucks. Consider that weekly recyclables pickup would require the purchase of an additional refuse truck and hiring an additional employee. Add to that the high price of diesel and you can see how it would be prohibitive in both cost and time for a dedicated recycle truck to drive throughout our neighborhood. And after collection, recyclables need to be transported to a private facility in the south valley, then bundled up and transported to Denver.

So, here is an option Larry suggested whereby SHS could help our community recycle. Depending upon community response he could make available a drop off area near the SHS office and we could bring our recyclables to them one afternoon a month. Now this would be for paper/newspaper/cardboard and plastics. Glass and aluminum have to be dropped off in one of the dumpsters behind Smith's. But this idea would be handy because it is closer than the other locales and shows community spirit.

I have also spoken to Ms. Kim McKibbon at the Solid Waste Dept of Bernalillo County. She is looking into options that might include a dumpster located along Tramway Blvd. Please do read the web page at bernco.gov and go to Solid Waste to become informed.

I would like to get an indication of how many residents would participate in this effort. Please call or email the SHHA office by September 30<sup>th</sup> if you would be interested.
