President's Message

Our recent Meet 'n' Greet featured a presentation by Dr. Mark DiMenna, Environmental Health Manager Vector Biologist with the City of Albuquerque Environmental Health Department. Dr. DiMenna is with the Vector-Borne and Zoonotic Disease Division. Given the elaborate title, he is in essence in charge of the City/County organization that is responsible for keeping the community free from diseases transmitted to humans from insects and animals. Although the division resides within the City of Albuquerque structure, they also serve all of Bernalillo County as well.

His discussion was very insightful for those who attended and the bottom line for Sandia Heights was that we live in an area susceptible to plague, hantavirus and encephalitis. For Sandia Heights there is not a problem with hantavirus or encephalitis, however, we do need to be aware of and alert for plague. The exposure to plague-infected animals and fleas increases as you get further into housing developments in the foothills of Sandia Mountains and in the East Mountain area. Exposure can increase during recreational activities, such as hiking and camping.

Plague can be contracted if one is bitten by infected rodent fleas and/or handles plague-infected tissues of sick or dead animals. Domestic cats can also contract plague and transmit it to humans. In addition to cats, dogs may carry plague-infected fleas into the home. If you encounter any dead animals near your property, please call 311 to report the sighting and ask for the Environmental Health Department to come out to remove the animal and test it for plague.

Additionally, if you note any animals that appear to be rabid or sickly, report them and the department will respond. You can also call Dr. DiMenna and his task force at 505-452-5301 or he can be reached personally on his mobile line at 505-263-3299. The goal of his organization is to keep the City, County and Sandia Heights healthy and happy and free from animal-borne diseases.

Spring Landscape Maintenance by Margo Murdock

Spring is the time of year when I do about 95% of my landscape maintenance. It's not by choice. I'd spread it over the year if I could it is just that spring is the best time for the plants. I've enjoyed the seed heads over the winter; have left the dry stalks standing so the base and roots are protected, and retained my lavender wands on the plant to help keep snow from sitting on the foliage. But it is spring and I have to think about what needs to be done and in what order to do it. Pruning sends a signal to the plant that it needs to put out new stems or branches to replace what's been cut. You'll see where autos have been stolen, houses broken into, and any assaults. There are many other types of crimes that are also reported.

Being that we are still in winter or early spring there isn't much or any vegetation

growth along our streets. However, with spring coming we will see a lot of growth. If there are any street edges that need trimming please let us know at SHHA so that we can consolidate areas into a list and give this to the county for maintenance.

Also please, please, please follow the safety reminders below.

Pedestrian Safety Reminders

- Walk **Facing** Traffic; make eye contact with drivers approaching you.
- Wear reflective vest or brightlycolored clothing, particularly in the evening.
- If you are walking a dog, keep the dog to your **left**.
- Whenever cars approach, a group of pedestrians should walk in single file.

SHHA Tree Removal Lottery Update

Dear Reader - Now Is the Time to Act!

Eighty-nine percent of our residents have stated that they were either very or somewhat concerned with undue obstruction of views by trees* Now is the time to act on our convictions and do our part to curtail, reduce, and reverse the otherwise relentless advance of trees into our distant mountain and valley views. *The SHHA Tree Lottery* now provides a excellent chance for all Association Members to have all or part of their tree removal costs paid for by the Association!

This winter has been particularly cold and snowy. Trees in the clutches of winter cold, winds, and drought appear dormant with no apparent growth. But under the ground, their roots continue to explore for new sources of water and nutrients, thus preparing for the burst of renewed growth which comes with spring. Once again, our larger tree species will resume their slow but deliberate assault on our valley and mountain views!

The CS&MC urges you to take action now. Are any of your trees interfering with your enjoyment of Sandia Mountain or the Rio Grande Valley? Are they interfering with the views of your neighbors? If the answer is yes, the time for action is now. Plan to have them removed before the SHHA Annual Meeting in June 2010 and enter the Lottery for a chance to have the cost reimbursed.

Lottery Rules

- Must be a member of the SHHA
- Trees must have been cut and removed after January 1, 2010
- Any size Siberian Elm** may be entered (including young sprouts)
- Siberian Elm** stumps must be treated to prevent re-growth
- Trees of all species over 26 feet high are eligible
- Trees on County rights-of-way are eligible
- Only Tree Owner can give permission

for tree removal

To Apply

- Fill out a Lottery application at the SHHA Office
- Provide a paid copy of the invoice for tree removal

Winners

- Drawings will follow the SHHA Annual Meeting in June 2010
- Need not be present to win
- Winners will receive actual cost of removal up to a maximum of \$750.00 per tree
- Drawings will continue until a total of \$5.000.00 has been awarded
